 - 5.1 Concerns brought up about home being cold
 - **5.1.1** <u>ACTION</u>: Jillian shared the FLTCA regulations on temperature, and advised to tell staff if they are uncomfortable with the temperature so it can be checked.
 - **5.2** Concern with doorbell in alcove taking a long time to answer in evenings
 - **5.2.1 ACTION:** Jillian explained visitor policy and the process for a formal complaint
 - **5.3** Question asked about the North Tower during redevelopment
 - **5.3.1** <u>ACTION</u>: Jillian explained how it is undetermined, but there is the possibility for it to be made into non-living spaces
 - **5.4** Question was asked about smoking
 - **5.4.1** <u>ACTION:</u> Jillian shared how we cannot force a resident to not smoke unless they are unsafe, and they come to her with individual concerns
 - **5.5** Questions were asked about the timing and order of resident's moving into the new building.

- **5.5.1** <u>ACTION</u>: Jillian discussed how there are building delays, and how the order of the move will be decided closer to moving.
- 5.6 A concern about food
 - **5.6.1** <u>ACTION:</u> Jillian invited the resident to attend the food committee meeting
- 5.7 It was asked if there would be a rent increase this year
 - **5.7.1 ACTION**: Jillian explained how it increases yearly on July 1st, that the rate is set by the MHLTC, and is based on taxes
- **5.8** Concern shared about a crack in the path in the oval garden, making it difficult for wheelchairs
 - **5.8.1 ACTION**: Request for repair sent to maintenance.
- **5.9** Resident shared they were missing a blanket that was sent to the laundry.
 - **5.9.1 ACTION:** Jillian advised them to follow up with U.M.
- **5.10** Resident shared that they moved to Cassellholme from a different LTC in Quebec, and that he likes this home better
- **5.11** Question was asked on visitor information during outbreaks
 - **5.11.1 ACTION:** Jillian shared that the RPN will have the most up-to-date information
